Takeaways

- The Fairgrounds is headed in the right direction.
- Fairgrounds redevelopment preserves our heritage and brings our community together with agricultural education and recreational opportunity for our kids.
 It is also important to implement safety improvements.
- The community prefers an inclusive approach to redeveloping the Fairgrounds.
- Based on community sensitivity to tax increases, all Fairgrounds user groups made significant sacrifices.
- There is a feasible public-private approach to implement an <u>inclusive but scaled</u>
 <u>back</u> phase II of Fairgrounds redevelopment.



Methodology

A set of one-on-one interviews with key community leaders and Fairgrounds stakeholders, including ice sports enthusiasts, youth agricultural educators and leaders, neighbors, business leaders, local elected officials and others. (N=36)

Scientifically valid telephone surveys, which were conducted by Harstad Strategic Research. Harstad is a well-respected research firm, with a long history of conducting community surveys in Missoula on important issues of the day. (N=1,450)





Key Findings Between Both Approaches

- The Missoula County Fairgrounds are viewed positively and are an important asset for Missoula County and the community.
- The public has preferences regarding the various components of the Fairgrounds redevelopment plan, but generally prefers for phase II to include all components.
- The research shows some level of tax sensitivity with respect to investing public dollars in the Fairgrounds.
- The most effective messages when
 communicating about the need to invest in
 Fairgrounds redevelopment reflect new
 educational opportunities for our kids,
 agriculture, more ice, and increased safety.

Interview Findings

The Missoula County Fairgrounds provides a **community gathering place** that allows **rural and urban folks to come together** in one location and intermix.

"It provides us an opportunity for people to come together and establish social and political common ground – on common ground."

Interview Findings

- Redevelopment of the Missoula County Fairgrounds should be a priority for the County.
- Favorite components of the plan included "connectivity" and green space, closely followed the livestock and equestrian center, and learning center with Butterfly House and Insectarium.
- Funding options—**blend** public and private funds.
- There is recognition among ice sports participants that demand for ice time exceeds the current capacity of Glacier lce Rink, but interviewees appear to be cost-sensitive when considering a new facility.

454 Likely November 2020 Voters January 12-14, 2020




Voters are overwhelmingly positive toward the tested entities in Missoula County

A Fairgrounds bond issue with average home costs in the low \$ double-digits initially elicits support from 2/3rds of the electorate – given three basic deliverables

"Shall the Board be authorized to issue bonds up to <u>\$15 Million</u> for redeveloping the Missoula County Fairgrounds including a new livestock and horse center for youth ad education such as 4-H, 10 acres of green park space including playgrounds.. and new ice rinks for year-round indoor hockey and ice sports. This bond issue would increase property taxes on a \$250,000 home by about <u>\$18 a year</u>."




Voters are price sensitive yet value a comprehensive Fairgrounds bond issue


July 2019: \$35M

New livestock center, rodeo arena, green space & ice rinks




August 2019: \$9M

New livestock center & 10 acres green space




January 2020: \$15M

In the July survey, voters clearly prioritized youth ag education, park space, and a new livestock center over other facilities



Suppose the building of the new ice rinks from this bond issue were supplemented with a commitment to raise several million dollars in private fundraising to help cover the full cost of building the ice rinks. Con Arguments Against the Fairgrounds Bond Issue

Next, I'm going to read you several reasons some people have given to vote AGAINST the proposed bond issue for new livestock and ice rink facilities at the county fairgrounds.

For each one, please tell me how convincing a reason you find it to vote AGAINST this county bond issue – extremely convincing, very convincing, fairly convincing, just somewhat convincing, or not at all convincing.

This is not the right time to raise property taxes. Most families and seniors are hard-pressed to make ends meet as it is. We already pay enough property taxes, and we cannot afford to pay more. **62%** *

The county took away horseracing, which was the heart and soul of the fairgrounds. Without horseracing, the fairgrounds is simply not worth the investment of more tax money. **35%** *

The fairgrounds have been neglected by the county for decades -- in spite of many broken past promises to restore it. At this point, instead the fairgrounds should just be moved out of town – or just torn down altogether. **21%** *

Pro Arguments for the Fairgrounds Bond Issue

Now, let me read you several reasons some people may give to vote FOR this proposed bond issue for new livestock and ice rink facilities at the county fairgrounds. For each one, please tell me how convincing a reason you find it to vote in favor of this county bond issue – extremely convincing, very convincing, fairly convincing, just somewhat convincing, or not at all convincing.

Year-round youth ag & stem type education – This investment will provide for the first time a livestock and horse center to offer year-round youth agricultural education programs like 4-H. **66%***

Ice rinks need adequate locker rooms- The current indoor ice rink & livestock building has inadequate locker rooms. The girls' changing rooms are located outdoors in a temporary trailer, and some of the boys' locker rooms are made of plywood with only space heaters. It doesn't meet building safety guidelines for sports facilities. 60%*

Ensure food & ag sustainability – Investing in a new livestock center for youth agricultural programming ensures that the next generation learns the skills necessary to sustain our local food and agricultural economy into the future. **59%***

Preserve county history and heritage – The fairgrounds have been a vital part of Missoula County for over100 years and contain many historic buildings. We should invest in preserving our fairgrounds and our connection to our agricultural heritage and traditions. **56%***

Major draw for families – This new livestock center and parkland would be a major fresh draw for our residents. It would include 10 acres of green space including park space, playgrounds, a band shell, picnic pavilions. It would become a much-used attraction for pedestrians, bicyclists, and families in an underserved neighborhood with heavy traffic. **57%***
