APPROXIMATELY 50 VOLUNTEER COACHES DONATED THEIR TIME FOR THESE PROGRAMS. MORE THAN 1,100 ADULTS TOOK PART IN OUR RECREATIONAL ADULT HOCKEY LEAGUES. WE HOSTED NINE YOUTH HOCKEY TOURNAMENTS AND THREE ADULT HOCKEY TOURNAMENTS, AS WELL AS A FIGURE SKATING COMPETITION, A CURLING BONSPIEL AND MORE THAN 30 JUNIOR HOCKEY GAMES.
